Configurable Rules Engine

StarCompliance Enterprise (STAR) is powered by a robust rules engine and configured to your organization's unique needs and policies. This leverages vast amounts of data, including employee information, user group and line of business relationships, and the donation thresholds you set to effectively automate contribution pre-clearance.

Timely, Collated Donation Data

Standardization of disclosed donations is severely lacking across the local, state, and federal levels, which puts a significant burden on compliance and all but eliminates their ability to surveil activity and reconcile donations in a timely manner. STAR aggregates data from the FEC, all 50 states, including municipalities, and provides donation information in a standardized format.

- On a daily basis as new donations are disclosed to the public, donations made by employees, or their family members, are collated and made available in STAR.
- Using the names and mailing addresses of employees and their family members, Star searches for likely matches, accounting for misspellings and common pseudonyms, powered by our database of over 14,000 name variations.
- Compliance is automatically notified when suspicious donations are made by an employee or family member.



Streamlined Compliance Workflows

> Employee Pre-Clearance

Monitored employees log into STAR to submit their political donation, completing a simple form collecting all the necessary information needed for documentation and approval purposes. The rules engine provides instant approval or denial. In situations where a review is required, the appropriate compliance team members are alerted.

> Employee Surveillance

With STAR, donation tracking and reconciliation becomes quick and easy. Using the names and mailing addresses of employees and their family members, donation searches are executed at the federal, state, and local levels. As donations are surfaced, compliance is alerted to reconcile pre-cleared donations, identify potential issues, and prompt necessary action.

> Case Management

In situations where an activity is flagged as suspicious and needs further investigation, cases can be created and managed within STAR. All relevant information, data, evidence, and donation history is collated and saved in one place for audit purposes and easy reference.
